Please Read The Following Rules Carefully

- 1] The law requires a Student to carry his/her temporary learner's permit while operating a motor vehicle.
- 2] If the Instructor is late for your appointment, please be patient. Call our office after 15 Min.
- 3] If you must cancel a driving lesson, a 24 hour notice must be given. Weekend appointments must be cancelled no later than 3:00 p.m. Friday. If we are not in the office, please leave a detailed message with our answering service. Failure to cancel or change an appointment within 24 hours, or Friday by 3:00 p.m. for weekend appointments, will result in a \$25.00 fee. This fee also applies if you do not have a VALID TEMPORARY PERMIT in your possession when the Instructor arrives; or for any reason you are not prepared to take your scheduled appointment. A student may be removed from the driving schedule until this fee is paid.
 *A valid temporary permit means you have taken and passed the computer test at the exam station.
- 4] AMS is not responsible for any items a student brings to the school or in the driver education vehicle. This includes, but is not limited to, the student's temporary permit.
- 5] If weather conditions are unfavorable, you will be notified and your lesson will be rescheduled.
- 6] Drive times may be scheduled once the account is paid in full. Once your driving lessons are scheduled, AMS will only contact you if we must change a lesson.
- 7] If you feel that you have not had proper and courteous instruction, please notify Management.
- 8] Parents are required to drive a minimum of 50 hrs. with their teenager. Ten of those hours have to be at night. This should be done before, during, and after instruction with the Driving School.
- 9] AMS reserves the right to deny the Student admittance to any class if the Student is tardy.
- 10] All students must be picked up from class on time. AMS is not responsible for any student left after class ends. Any student not picked up on time, may be removed from the program with no refund.
- 11] AMS reserves the right to cancel this agreement at any time, should the Student's conduct indicate a lack of responsibility deemed necessary by AMS to safely operate a motor vehicle. Refunds are considered on an individual basis, and will be pro-rated accordingly. Any student told to leave the program due to improper behavior, will receive no refund.
- 12] AMS is not responsible for any student leaving the school during break; however, inappropriate behavior during the break may result in the student being expelled from the program with no refund.
- 13] Training will be made available to the student within six months of the date started. This agreement expires on _____, _____. There will be no refunds provided after that time. Upon expiration of this agreement, a reinstatement fee equal to the current cost of the course will be charged before any further services are provided. Also, the student will need to repeat the 24 hours of class and 8 hours of driving.

- 14] AMS shall furnish a certificate of completion to all students (under the age of eighteen years) who successfully complete the course. Completion, as defined by the State of Ohio, "Instruction is based upon the Ohio Driver's Training Curriculum," refers to the completion of the required number of hours, the student's good faith effort having been exercised during the practical driving portion, and the attainment of a score equal to or greater than 75% on the final written test in class. Should a Student fail to achieve the minimum passing score on the final exam after three attempts, the Student will be required to repeat the 24 hrs of class time at an additional fee of \$150.00.
- 15] All Certificates of Completion will be mailed to the student after all instruction has been completed and the student's account is paid in full. NO EXCEPTIONS. AMS is not responsible for certificates lost in the mail.
- 16] If you lose your Certificate of Completion, the fee for issuing a duplicate is \$4.00. This includes but not limited to certificates lost in the mail.
- 17] Any citation issued to a student during the practical training is the responsibility of the student and their parent. This includes camera surveillance.
- 18] AMS reserves the right to refuse any person (including, but not limited to, student and/or parent) service for any reason before, during, and after instruction is complete. This will result in the person receiving no refund.

The School shall furnish a licensed Instructor and a motor vehicle for instruction. The Driving School does not guarantee the issuance of a driver's license to the student.

Driver training schools are licensed by the Department of Public Safety through the Driver Training Program Office, 1970 West Broad St., Columbus, OH 43223

The Teen Driver Education Course consists of:

- A) 24 hours of classroom instruction as specified (Rule 4501-7-10)
- B) 8 hours of practical driving instruction as specified (Rule 4501-7-10)

Full Course Cost: \$350.00/\$75.00 Down or \$325.00 P-I-F on first day of class. A fee of \$35.00 is charged for returned checks. The Student may be removed from the driving schedule until such check is made good.

(Optional) Please contact our office prior to scheduling road test for either location. AMS does not guarantee the same car the Student practiced in.

Use of vehicle for State driving test in Lucas County: If you have a ride to our office: \$25.00. If an instructor needs to pick you up and bring you to the exam station: \$40.00.

Use of vehicle for State driving test in Wood County: \$60.00
